- For your safety and protection, this dehumidifier is equipped with a three-prong grounding plug on the power cord. Do not, under any circumstances, cut or remove the round ground prong from the plug.
- Your dehumidifier must be plugged directly into a properly grounded and polarized three-prong receptacle. If the wall receptacle you intend to use will not

- accept a three-prong plug, or if you are not sure the outlet is adequately grounded or protected by a time delay fuse or circuit breaker, have a qualified electrician install the proper outlet according to the National Electrical Code and applicable local codes and ordinances. Do not use an extension cord or an adapter plug.
- Never unplug the dehumidifier by pulling on the power cord. Always grip the plug firmly and pull straight out from the receptacle.
- Do not pinch, bend, or knot the power cord.

#### **Child Safety Precautions**

 Destroy the carton, plastic bags, and any packing materials immediately after the dehumidifier is unpacked. Children should never use these items for play.

- Do not leave children unattended in an area where the appliance is operating. Do not allow them to sit or stand on the appliance.

- This dehumidifier contains no user-serviceable parts. Always call an authorized Electrolux servicer for repairs.
- Do not insert or place fingers or objects into the air discharge area or back grille of the unit.
- Do not start or stop the dehumidifier by unplugging the power cord or turning off the power at the electrical box.
- Do not cut or damage the power cord. Do not pull on the power cord.
- If the power cord is damaged, it should only be replaced by an authorized Electrolux servicer.
- In the event of a malfunction (sparks, burning smell, etc.), immediately stop the operation, disconnect the power cord, and call an authorized Electrolux servicer.
- Do not operate the dehumidifier with wet hands. Do not drink any water from the dehumidifier.
- If the supply cord is damaged, it must be replaced by the manufacturer, its service agent or similarly qualified persons in order to avoid a hazard.
- The appliance shall be installed in accordance with national wiring regulations.


- Do not direct airflow at fireplaces or other heat related sources as this could cause flare ups.
- Do not climb on or place objects on the unit. Do not hang objects off the unit.
- Do not place containers with liquids on the unit.
- Turn off the dehumidifier at the power source when it will not be used for an extended period of time.
- Operate the unit with air filter in place.
- Do not block or cover the intake grille, discharge area and outlet ports.
- Ensure that any electrical/electronic equipment is one yard away from the unit
- Do not use or store flammable gases near the unit.

# **WARNING**

#### FOR FLAMMABLE REFRIGERANT

- Servicing shall only be performed as recommended by the equipment manufacturer. Maintenance and repair requiring the assistance of other skilled personnel shall be carried out under the supervision of the person competent in the use of flammable refrigerants.
- DO NOT modify the length of the power cord or use an extension cord to power the unit.
- DO NOT share a single outlet with other electrical appliances. Improper power supply can cause fire or electrical shock.
- Please follow the instruction carefully to handle, install, clear, service the air conditioner to avoid any damage or hazard.
- Flammable Refrigerant R32 is used within air conditioner. When maintaining or disposing the air conditioner, the refrigerant (R32) shall be recovered properly, shall not discharge to air directly.
- Compliance with national gas regulations shall be observed.
- Keep ventilation openings clear of obstruction.
- The appliance shall be stored so as to prevent mechanical damage from occurring.
- A warning that the appliance shall be stored in a well-ventilated area where the room size corresponds to the room area as specified for operation.
- Any person who is involved with working on or breaking into a refrigerant circuit should hold a current valid certificate from an industry-accredited assessment authority, which authorises their competence to handle refrigerants safely in accordance with an industry recognised assessment specification.

Examples for such working procedures are:

- breaking into the refrigerating circuit:
- opening of sealed components;
- opening of ventilated enclosures.

- No any open fire or device like switch which may generate spark/arcing shall be around air conditioner to avoid causing ignition of the flammable refrigerant used. Please follow the instruction carefully to store or maintain the air conditioner to prevent mechanical damage from occurring.
- Do not use means to accelerate the defrosting process or to clean, other than those recommended by the manufacturer.
- The appliance shall be stored in a room without continuously operating ignition sources (for example: open flames, an operating gas appliance) and ignition sources or (for example: an operating electric heater) close to the appliance.
- · Do not pierce or burn.
- Be aware that the refrigerants may not contain an odour.
- 1. Transport of equipment containing flammable refrigerants.

# **4.Storage of equipment/appliances**The storage of equipment should be in accordance with the manufacturer's

5. Storage of packed (unsold) equipment

Storage package protection should be constructed such that mechanical damage to the equipment inside the package will not cause a leak of the refrigerant charge. The maximum number of pieces of equipment permitted to be stored together will be determined by local regulations.

#### 6. Information on servicing

a) Checks to the area

instructions.

Prior to beginning work on systems containing flammable refrigerants, safety checks are necessary to ensure that the risk of ignition is minimised. For repair to the refrigerating system, the following precautions shall be complied with prior to conducting work on the system.

#### b)Work procedure

Work shall be undertaken under a controlled procedure so as to minimise the risk of a flammable gas or vapour being present while the work is being performed.

#### c) General work area

All maintenance staff and others working in the local area shall be instructed on the nature of work being carried out. Work in confined spaces shall be avoided. The area around the workspace shall be sectioned off. Ensure that the conditions within the area have been made safe by control of flammable material.

- d)Checking for presence of refrigerant
  The area shall be checked with an
  appropriate refrigerating detector prior
  to and during work, to ensure the
  technician is aware of potentially
  flammable atmospheres. Ensure that the
  leak detection equipment being used is
  suitable for use with flammable
  refrigerants, i.e. non-sparking,
  adequately sealed or intrinsically safe.
- e) Presence of fire extinguisher

  If any hot work is to be conducted on
  the refrigeration equipment or any
  associated parts, appropriate fire
  extinguishing equipment shall be
  available to hand. Have a dry powder or
  CO2 fire extinguisher adjacent to the
  charging area.

#### f) No ignition sources

No person carrying out work in relation to a refrigerating system which involves exposing any pipe work that contains or has contained flammable refrigerant shall use any sources of ignition in such a manner that it may lead to the risk of fire or explosion. All possible ignition sources, including cigarette smoking, should be kept sufficiently far away from the site of installation, repairing, removing and disposal, during which flammable refrigerant can possibly be released to the surrounding space. Prior to work taking place, the area around the

equipment is to be surveyed to make sure that there are no flammable hazards or ignition risks. No Smoking signs shall be displayed.

#### g)Ventilated area

Ensure that the area is in the open or that it is adequately ventilated before breaking into the system or conducting any hot work. A degree of ventilation shall continue during the period that the work is carried out. The ventilation should safely disperse any released refrigerant and preferably expel it externally into the atmosphere.

- h) Checks to the refrigerating equipment Where electrical components are being changed, they shall be fit for the purpose and to the correct specification. At all times the manufacturer's maintenance and service guidelines shall be followed. If in doubt consult the manufacturer's technical department for assistance. The following checks shall be applied to installations using flammable refrigerants: The actual refrigerant charge is in accordance with the room size within which the refrigerant containing parts are installed; The ventilation machinery and outlets are operating adequately and are not obstructed; If an indirect refrigerating circuit is being used, the secondary circuit shall be checked for the presence of refrigerant; Marking to the equipment continues to be visible and legible. Markings and signs that are illegible shall be corrected; Refrigerating pipe or components are installed in a position where they are unlikely to be exposed to any substance which may corrode refrigerant containing components, unless the components are constructed of materials which are inherently resistant to being corroded or are suitably protected against being so corroded.
- i) Checks to electrical devices
  Repair and maintenance to electrical
  components shall include initial safety
  checks and component inspection
  procedures. If a fault exists that could
  compromise safety, then no electrical
  supply shall be connected to the circuit
  until it is satisfactorily dealt with. If the
  fault cannot be corrected immediately
  but it is necessary to continue operation,
  an adequate temporary solution shall be

used. This shall be reported to the owner of the equipment so all parties are advised. Initial safety checks shall include: That capacitors are discharged: this shall be done in a safe manner to avoid possibility of sparking; That there no live electrical components and wiring are exposed while charging, recovering or purging the system; That there is continuity of earth bonding.

#### 7. Repairs to sealed components

- a) During repairs to sealed components, all electrical supplies shall be disconnected from the equipment being worked upon prior to any removal of sealed covers, etc. If it is absolutely necessary to have an electrical supply to equipment during servicing, then a permanently operating form of leak detection shall be located at the most critical point to warn of a potentially hazardous situation.
- b)Particular attention shall be paid to the following to ensure that by working on electrical components, the casing is not altered in such a way that the level of protection is affected. This shall include damage to cables, excessive number of connections, terminals not made to original specification, damage to seals, incorrect fitting of glands, etc. Ensure that apparatus is mounted securely. Ensure that seals or sealing materials have not degraded such that they no longer serve the purpose of preventing the ingress of flammable atmospheres. Replacement parts shall be in accordance with the manufacturer's specifications.

NOTE: The use of silicon sealant may inhibit the effectiveness of some types of leak detection equipment. Intrinsically safe components do not have to be isolated prior to working on them.

#### 8. Repair to intrinsically safe components

Do not apply any permanent inductive or capacitance loads to the circuit without ensuring that this will not exceed the permissible voltage and current permitted for the equipment in use. Intrinsically safe components are the only types that can be worked on while live in the presence of a flammable atmosphere. The test apparatus shall be at the correct rating.

Replace components only with parts specified by the manufacturer. Other parts may result in the ignition of refrigerant in the atmosphere from a leak.

#### 9. Cabling

Check that cabling will not be subject to wear, corrosion, excessive pressure, vibration, sharp edges or any other adverse environmental effects. The check shall also take into account the effects of aging or continual vibration from sources such as compressors or fans.

#### 10. Detection of flammable refrigerants

Under no circumstances shall potential sources of ignition be used in the searching for or detection of refrigerant leaks. A halide torch (or any other detector using a naked flame) shall not be used.

The following leak detection methods are deemed acceptable for systems containing flammable refrigerants. Electronic leak detectors shall be used to detect flammable refrigerants, but the sensitivity may not be adequate, or may need re-calibration. (Detection equipment shall be calibrated in a refrigerant-free area). Ensure that the detector is not a potential source of ignition and is suitable for the refrigerant used. Leak detection equipment shall be set at a percentage of the LFL of the refrigerant and shall be calibrated to the refrigerant employed and the appropriate percentage of gas (25 % maximum) is confirmed. Leak detection fluids are suitable for use with most refrigerants but the use of detergents containing chlorine shall be avoided as the chlorine may react with the refrigerant and corrode the copper pipe-work. If a leak is suspected, all naked flames shall be removed/extinguished. If a leakage of refrigerant is found which requires brazing, all of the refrigerant shall be recovered from the system, or isolated (by means of shut off valves) in a part of the system remote from the leak. Removal of refrigerant shall be according to Removal and evacuation.

#### 11. Removal and evacuation

When breaking into the refrigerant circuit to make repairs – or for any other purpose–conventional procedures shall be used. However, for flammable refrigerants it is important that best practice be followed, since flammability is a consideration. The following procedure shall be adhered to:

- a) safely remove refrigerant following local and national regulations;
- b)purge the circuit with inert gas:
- c) evacuate (optional for A2L);
- d)purge with inert gas (optional for A2L);
- e) open the circuit by cutting or brazing.

The refrigerant charge shall be recovered into the correct recovery cylinders if venting is not allowed by local and national codes. For appliances containing flammable refrigerants, the system shall be purged with oxygen-free nitrogen to render the appliance safe for flammable refrigerants. This process might need to be repeated several times. Compressed air or oxygen shall not be used for purging refrigerant systems. For appliances containing flammable refrigerants, refrigerants purging shall be achieved by breaking the vacuum in the system with oxygen-free nitrogen and continuing to fill until the working pressure is achieved, then venting to atmosphere, and finally pulling down to a vacuum (optional for A2L). This process shall be repeated until no refrigerant is within the system (optional for A2L). When the final oxygen-free nitrogen charge is used, the system shall be vented down to atmospheric pressure to enable work to take place. Ensure that the outlet for the vacuum pump is not close to any potential ignition sources and that ventilation is available.

#### 12. Charging procedures

In addition to conventional charging procedures, the following requirements shall be followed. Ensure that contamination of different refrigerants does not occur when using charging equipment. Hoses or lines shall be as short as possible to minimise the amount of refrigerant contained in them. Cylinders shall be kept in an appropriate position according to the instructions. Ensure that the refrigeration system is earthed prior to charging the system with refrigerant. Label the system when charging is complete (if not already). Extreme care shall be taken not to overfill the refrigeration system. Prior to recharging the system it shall be pressure tested with OFN. The system shall be leak tested on completion of charging but prior to commissioning. A follow up leak test shall be carried out prior to leaving the site.

#### 13.Decommissioning

Before carrying out this procedure, it is essential that the technician is completely familiar with the equipment and all its detail. It is recommended good practice that all refrigerants are recovered safely. Prior to the task being carried out, an oil and refrigerant sample shall be taken in case analysis is required prior to re-use of reclaimed refrigerant. It is essential that electrical power is available before the task is commenced.

- a) Become familiar with the equipment and its operation.
- b)Isolate system electrically.
- c) Before attempting the procedure ensure that: Mechanical handling equipment is available, if required, for handling refrigerant cylinders; All personal protective equipment is available and being used correctly; The recovery process is supervised at all times by a competent person; Recovery equipment and cylinders conform to the appropriate standards.
- d)Pump down refrigerant system, if possible.

- e)If a vacuum is not possible, make a manifold so that refrigerant can be removed from various parts of the system.
- f) Make sure that cylinder is situated on the scales before recovery takes place.
- g)Start the recovery machine and operate in accordance with instructions.
- h)Do not overfill cylinders. (No more than 80% volume liquid charge).
- Do not exceed the maximum working pressure of the cylinder, even temporarily.
- j) When the cylinders have been filled correctly and the process completed, make sure that the cylinders and the equipment are removed from site promptly and all isolation valves on the equipment are closed off.
- k) Recovered refrigerant shall not be charged into another refrigeration system unless it has been cleaned and checked.

#### 14.Labelling

Equipment shall be labelled stating that it has been de-commissioned and emptied of refrigerant. The label shall be dated and signed. Ensure that there are labels on the equipment stating the equipment contains flammable refrigerant.

#### 15.Recovery

When removing refrigerant from a system, either for servicing or decommissioning, it is recommended good practice that all refrigerants are removed safely. When transferring refrigerant into cylinders, ensure that only appropriate refrigerant recovery cylinders are employed. Ensure that the correct number of cylinders for holding the total system charge is available. All cylinders to be used are designated for the recovered refrigerant and labelled for that refrigerant (i.e. special cylinders for the recovery of refrigerant). Cylinders shall be complete with pressure relief valve and associated shut-off valves in good working order. Empty recovery cylinders are evacuated and, if possible, cooled before recovery occurs.


The recovery equipment shall be in good working order with a set of instructions concerning the equipment that is at hand and shall be suitable for the recovery of flammable refrigerants. In addition, a set of calibrated weighing scales shall be available and in good working order. Hoses shall be complete with leak-free disconnect couplings and in good condition. Before using the recovery machine, check that it is in satisfactory working order, has been properly maintained and that any associated electrical components are sealed to prevent ignition in the event of a refrigerant release. Consult manufacturer if in doubt. The recovered refrigerant shall be returned to the refrigerant supplier in the correct recovery cylinder. and the relevant Waste Transfer Note arranged.

Do not mix refrigerants in recovery units and especially not in cylinders.

If compressors or compressor oils are to be removed, ensure that they have been evacuated to an acceptable level to make certain that flammable refrigerant does not remain within the lubricant. The evacuation process shall be carried out prior to returning the compressor to the suppliers. Only electric heating to the compressor body shall be employed to accelerate this process. When oil is drained from a system, it shall be carried out safely.


Non-duct connected appliances containing A2L refrigerants with the supply and return air openings in the conditioned space may have the body of the appliance may be installed in open areas such as false ceilings not being used as return air plenums, as long as the conditioned air does not directly communicate with the air of the false ceiling.



### 2.2 Quick Glance Light Behavior

Situation	Quick Glance Light Behavior
In Quiet or Continuous mode.	The light will turn off.
In Dry or Auto mode, when ambient humidity is at or higher the set humidity.	The light will turn off.
In Dry or Auto mode, when ambient humidity is lower then set humidity.	The light will continuously emit a blue light to show the set humidity has been reached.
When bucket full or clean filter light is on.	The light will emit orange light and gradually turn dark and bright every 4 sec.
When E4, EC, AS or ES error occur.	The light will emit red light and gradually turn dark and bright every 4 sec.

### 3. BEFORE FIRST USE

# 3.1 Selecting a Location

#### IMPORTANT

- 1. Appliance must be upright for one hour prior to operating.
- Place the appliance in a location with minimum 20cm distance around the unit (at least 40cm of air space on air outlet).
- 3.A dehumidifier operating in a basement will have little or no effect in drying an adjacent enclosed storage area, such as a closet, unless there is adequate circulation of air in and out of the area.
- 4. The dehumidifier must be installed on a level floor that will support it with a full bucket of water.
- 5. The presence of water in the water tank during first use is normal.

### 3.2 How It Works

- 1.The unit is designed to operate between 41°F (5°C), and 95°F (35°C). The unit will not work properly if the temperature is out of this temperature range, or the performance of the unit decreases greatly.
- The compressor circuit has an automatic 3-minute time delayed start if the unit is turned off and on quickly. This prevents overheating of the compressor and possible circuit breaker tripping.
- If the appliance is unplugged or the electricity has been cut off when the unit is operating, the unit will set back to previous setting after the power is on again.

### 4. OPERATING INSTRUCTIONS

### 4.1 Usage of the Control Panel

Allow the unit to reach room temperature before operating. To begin operating the dehumidifier, follow these steps:

**NOTE:** Unit must be upright for one hour prior to operating.

1. make sure the appliance is plugged in correctly.

**NOTE:** If the "" Iight is on, remove the water tank and re-install to reset the float switch.



2. Press "(1)" to turn on the appliance. The appliance will run in the default setting of Auto mode. In this mode, the appliance will automatically set a comfortable humidity and fan speed according to the indoor environment.

**NOTE:** In this mode, set humidity and fan speed can not be changed manually and the display will show actual room humidity.



3. To use Quiet mode, press the Mode button to choos Quiet mode. The unit will run in low fan speed for the whole time and the unit will automatically set a comfortable humidity according to the indoor environment.

**NOTE:** In this mode, set humidity and fan speed can not be change manually and the display will show actual room humidity.



4. To use Dry mode, press the Mode button to choos Dry mode. In this mode, you can press the "-" or "+" buttons to choose a humidity value between 35% to 85%, so the room is kept at a comfortable humidity. Pressing the - or + buttons will change the humidity selection in 5% increments. 5 seconds after you have set the desired humidity, the readout will display the actual room humidity.



5. During the Dry mode, You can also use the FAN SPEED button to change the fan speed to Hi, Med or Lo. The indicator light will show the setting you have selected. A higher fan speed will result in quicker moisture removal.



6. To use CONTINUOUS mode, when in Dry mode pressing the " - " button until the display reads CO. In this mode, the unit will continuously on and the unit will only display CO not the room humidity. To leave this mode, press the " + " button.



7. The TIMER function enables you to either Delay Start or Delay Stop the unit in the choice from 0.5 hour to 24 hours. If the unit is running, then selecting Timer will turn the unit off in the hours that will be set (Delay Stop). If the unit is off, then selecting Timer will turn the unit on in the hours that will be set (Delay Start), TIMER setting: First press TIMER button, then adjust timer setting, by tapping or holding the " - " or " + " button to change the delay timer at 0.5 hour increments, up to 10 hours, then by 1 hour increments up to 24 hours. The control will count down the time remaining (8h, 7.5h, 7h etc.) until the unit either starts or stops. For the Delay Start, the fan speed and humidity maintained will be the same as previous setting. After TIMER setting finishes. pressing TIMER button again at any time will stop the TIMER function. The Delay Start/Stop Feature will work until the unit either starts or stops. Once that happens the above steps have to be repeated.



#### NOTE:

- Before entering TIMER setting, make sure power is being supplied to the unit.
- Before entering TIMER setting, select a desired setting for operation when the unit turn on.
- 8. The Filter reset light will illuminate after 250 hours of operation. At this time refer to the care and cleaning section to remove and clean the filter. Once the filter has been cleaned and replaced, simply press the Filter reset button to extinguish the light.



 Press and hold the " - " and " + " for 3 sec can activate or deactvate the LOCK function. The display will show LC for 5 secs. The control panel will be lock and the setting can not be changed.



10. The appliance is equipped with a Wi-Fi chip that enables it to be connected to the internet and via the App enables you to control and access its full functionality remotely. Download our App and follow the instructions for how to connect your appliance to the internet. When the connection is established, the "" " indicator will light up. (seleted units only)



- 11. The unit is equipped with a device called an ionizer. This device can only be activated and deactivated via the App, which can be downloaded onto your smart phone device. When the ionizer is activated, it will help to reduce airborne pollutants and clean your room's air faster.
- 12.Press "(1)" to turn off the appliance.

**NOTE:** After a power outage, the unit will memorize the last setting and return the unit to the same setting once power is restored.



### 4.2 Fault Codes

 If the display reads "AS" or "ES", a sensor has failed. Contact your Authorized Electrolux Service Center.



2. If the display reads "EC", check the following operating conditions. Outlet voltage should be 110V±10% and the surrounding temperature should be with in the range of 41 °F to 89 °F. Unplug the unit and plug it in again under normal operating conditions. If the "EC" code persists, contact your Authorized Electrolux Service Center.



 If the display reads "E4", the communication between display PCB and main control PCB is faulty. Contact your Authorized Electrolux Service Center.





### 4.3 Removing Collected Water


- 1. Emptying the water tank:
- a. When the water tank is full, the unit will shut down and the "" indicator will illuminate.




- b. Do not move the unit at this time otherwise water may spill on the floor.
- c. Press sides of bucket gently to unclip the bucket from the unit.
- d. Remove the bucket as shown in the photographs below and empty the bucket.












# **WARNING**

Discard water from bucket. Water is not potable and cannot be used for drinking.

- e. Replace the empty bucket back into the unit and once seated correctly, the unit will start up again.
- f. You should hear a click when the bucket is in the correct position.


If the bucket full light does not extinguish, check that the float is correctly snapped in place.




- 2. Continuous Drainage:
- a. For continuous drainage operation, you will need a drainage hose, drainage adaptor(sold separately) and a drain nearby to discharge the water into.

**Note:** Drainage hose and adaptor are not coming with dehumidifier, more information please contact Electrolux service center.


b. Unscrew the drainage cap on the back side of the unit. (fig.1)




c. Connect the drainage adaptor to the drain outlet. And Screw the adaptor.(fig.2)



e. Connect one end of the drainage hose to the drainage adaptor. Make sure the hose is secure so there are no leaks. (fig.3)



g. Lead the other end of drainage hose into a drain that is lower than the unit. (fig.4)



h. Select the desired humidity setting and fan speed on the unit for continuous draining to start.

#### NOTE:

- Check the seal between the hose and the drainage adaptor. If there is a small leak then replace the hose gasket and re-tighten the hose.
- It is recommended that a Dehumidifier Drainage Hose - inner diameter 13.5mm(outer diameter 16.5mm). Make sure there are no kinks or elevations in the hose.
- Please ensure drainage adaptor is screwed securely to the drain outlet to prevent leakages.


### 5. CARE AND CLEANING

### 5.1 Filter


Clean the filter every two weeks based on normal operating conditions.

To remove the filter:

a. Open the back grille.



 b. Detach the filter from the back of the grille by pressing the tabs as shown below.



- c. Wash the filter with clean water then dry.
- d. Re-install the filter.

#### 5.2 Cabinet

- a. Dust cabinet with an oil-free cloth, or using a damp cloth.
- b. Vacuum grill using brush attachment.
- 3. Water Bucket


Clean the Water Bucket every two weeks based on normal operating conditions.

a. Clean bucket with warm water and detergent.

**NOTE:** This unit has available space for use of additional filters. There are different types of additional filters, which are sold separately. You can purchase additional air filters by visiting electrolux.com


### 5.3 Storage

a. Unplug the appliance, then tidy up the power cord using the tag at the back of the unit.



- b. Empty the water tank and clean the
- c. Dry the appliance and all accessories by airing.
- d. Pack it with plastic bag or return it to its carton then place the unit in a cool and dry place.

### 5.4 Normal Sounds



1 Dripping Sound

The sound of dripping water may be heard during the dehumidification cycle.

2 Sound of Rushing Air

At the top of the unit, you may hear the sound of rushing air being moved by the fan.

**3** Gurgle/Hiss

"Gurgling or hissing" noise may be heard due to refrigerant passing through evaporator during normal operation.

4 High Pitched Chatter

Today's high efficiency compressors may have a high pitched chatter during the dehumidification cycle.



### a) 使作業區域保持通風

### i) 檢查電器裝置

### 8. 維修本質安全元件

請勿對電路施加任何永久電感或電容負載,除非確保這不會超過所用設備允許的電壓和電流。本質安全元件是唯一可在有可燃性氣體的情況下活電作業的類型。測試裝置的額定值應正確。僅使用製造商指定的零件來更換元件。其他零件可能導致冷媒因洩漏而在空氣中點燃。

### 9. 佈線

檢查佈線是否會受到磨損、腐蝕、過 高壓力、震動、銳利邊緣或任何其他 不利的環境影響。檢查也應將來自壓 縮機或風扇等來源的老化或持續震動 的影響納入考量。

### 10. 偵測可燃性冷媒

在任何情況下,均不得在搜尋或偵測 冷媒洩漏時使用潛在點火源。不得使 用鹵素燈(或任何其他使用明火的偵 測器)。

就含有可燃性冷媒的系統而言,以下 洩漏偵測方法被視為可接受。應使用 電子洩漏偵測器偵測可燃性冷媒,但 靈敏度可能不足,或可能需要重新校 正。(應在無冷媒的區域校正偵測設 備。)確保偵測器並非潛在點火源目 適合使用的冷媒。應將洩漏偵測設備 設定在冷媒的易燃下限百分比並依照 採用的冷媒進行校正,且確認適當的 氣體百分比(最大25%)。洩漏偵測 液適用於大多數冷媒,但應避免使用 含氯清潔劑,因為氯可能會與冷媒產 牛 反應並腐蝕銅管。如果懷疑洩漏, 則應移除 / 熄滅所有明火。如果發現 冷媒洩漏而需要銅焊,應從系統回收 所有冷媒,或隔離(透過關斷閥)在 遠離洩漏處的系統部分。應遵照移除 和排空法規移除冷媒。

### 11. 移除和排空

為了進行維修或任何其他目的而接觸 冷媒迴路時,應採用慣例程序。但遵 循最佳實務很重要,因為可燃性是一 大考量。應遵守以下程序:

- al 安全地依照當地和國家法規移除冷媒
- b) 惰性氣體迫淨迴路
- c) 排空(A2L選項)
- d) 用惰性氣體迫淨 (A2L選項)
- e) 透過切割或銅焊開啟迴路。若當地和 國家規定不允許排放,應將冷媒回收 至下確的回收鋼瓶。含有可燃性冷媒 的電器,應使用無氧氮氣(OFN)「沖 洗」系統以確保裝置安全。可能要多 次重複此過程。不得將壓縮空氣或氧 氣用於此任務。針對含可燃性冷媒的 電器,沖洗方式應是使用OFN 破壞系 統中的真空並繼續充填直到達到工作 壓力,然後排放至空氣中,最後抽真 空(A2L選項)。應重複此過程,直到系 統內沒有冷媒為止。

使用最終OFN充填時,應將系統排放 至大氣壓力以便進行作業。確保真空 泵浦的出口未靠折任何點火源日涌風 良好。

### 12. 充填程序

除了慣例的充填程序之外,應遵守下 列方式:確保使用充填設備時未出現 不同冷媒的汗染。管線應盡量縮短以 減少內含冷媒。

鋼瓶應依照指示放置。為系統充填冷 媒之前,確保製冷系統接地。充填完 成後標示系統 (若尚未進行)。

應特別小心不要過度充填製冷系統。 充填系統前應使用OFN進行壓力測 試。應在充填完成後但未啟用前對系 統進行洩漏測試。離開現場前應進行 追蹤洩漏測試。

### 13. 停用

執行此程序前技術人員必須完全熟悉 設備及其所有細節。建議的良好做法 是安全回收所有冷媒。執行任務前應 取得油和冷媒樣本,以防在重複使用 回收的冷媒前需要分析。開始任務前 必須有電力可用。

- a) 熟悉設備及其操作。
- b) 對系統進行電氣隔離。
- c)執行程序前請確保:可視需要使用機 械搬運設備搬運冷媒鋼瓶;準備並正 確使用所有個人防護裝備:回收過程 全程由合格人員監督:回收設備和鋼 瓶符合相關標準。
- d) 如果可能,請抽空冷媒系統。

- e) 如果無法建立真空,則製作歧管,以 便從系統各部分移除冷媒。
- f) 進行回收前確保鋼瓶位於計重秤上。
- g) 啟動回收機器並依照製造商的指示操作。
- h) 請勿過度充填鋼瓶。 (不超過 80% 容積液體充填量)。
- i) 請勿超過鋼瓶的最大工作壓力,即使 暫時超過也一樣。
- j) 正確充填鋼瓶並完成程序後,立即從 現場移走鋼瓶和設備並關閉設備上的 所有隔離閥。
- k) 不得將回收的冷媒充填至另一個製冷 系統,除非經過清潔和檢查。

### 14. 標示

設備應貼上標籤,說明已停用並排空 冷媒。應在標籤上註明日期並簽名。 確保設備上有說明設備含有可燃性冷 媒的標籤。

### 15. 回收

回收設備應處於良好狀態並附有關於 設備的說明,且應適用於回收可燃性 冷媒。此外,應準備經過校正並處於 良好狀態的計重秤。

軟管應配無洩漏分離接頭並處於良好狀態。使用回收機器前請確定機器處於正常運作狀態、得到妥善維護,所有相關電氣元件已密封以防在冷媒釋放時燃起。如有疑問,請諮詢與造商。應使用正確的回收鋼瓶將回收期間的廢棄物轉運單。請勿在回收裝置中混合冷媒,尤其是鋼瓶內。

若要移除壓縮機或壓縮機油,請確保已排空至可接受的程度,確定可燃性冷媒不會殘留在潤滑劑中。應在將壓縮機送回給供應商前進行排空程序。只能採用對壓縮機本體進行電加熱來加快此過程。從系統排油時,應以安全的方式進行。

含有A2L冷媒的無管電器在適宜位置 有送風口和回風口的電器主體可以安 裝於開放區域,像是不能作為回風區 的偽天花板,前提是空調不直接對應 偽天花板的空氣。





# 3. 首次使用之前


